BND will participate up to 90 percent of the total loan amount, not to exceed a maximum participation of \$250,000. Standard underwriting procedures will apply to all loans. All applications must be submitted by a local lender. <b>Livestock Forage Disaster Program</b>	U.S. Department of Agriculture, Farm Service Agency	Producers apply through FSA to receive LFP payments for drought are equal to 60 percent of the monthly feed cost for up to five months. <b>Livestock Indemnity Program</b>	U.S. Department of Agriculture, Farm Service Agency	Producers apply through the FSA for benefits if they have legally owned the eligible livestock on the day they died. The livestock must also: have died due to an eligible weather event, which occurred on or after October 1, 2011, and no later than 60 days from the end date of the event.
