ERG PURPOSE

"Private companies operating in North Dakota are eligible to receive funding for costs associated with improvements to their businesses for the purpose of reducing the spread of infection, and instilling consumer confidence in the marketplace."



ERG ELIGIBILITY

Private companies operating in North Dakota are eligible to receive funding for costs associated with improvements to their businesses for the purpose of reducing the spread of COVID-19 to instill consumer confidence in the marketplace.



ERG INELIGIBILITY

- Businesses with no live customer interaction*
- At-home businesses*
- Governmental, Regulatory, and Public Administrative Entities*
- Lobbying organizations*



ERG ELIGIBLE EXPENSES

"Direct investment to reduce the spread of infection."



APPLICATION PROCESS

- Online application
- Apply starting July 31 (first come, first serve)
- Additional training and resources available



POST AWARD OBLIGATIONS AND OPPORTUNITIES

- Use funds as proposed within 45 days
- Submit documentation to support expenditures (or return funds)
- NDSmart Restart webpage "badge" and materials
- Self-Certification of compliance with NDSmart Restart Protocol (in development)
